A Boy Named Sam

"My boy, you must get a little memorandum-book, and every time I tell you a thing, put it down right away. There's only one way to be a pilot, and that is to get this entire river by heart. You have to know it just like A B C." Sam received this advice from Horace Bixby, the river pilot who "learned" him the river, and he complied in the extreme, writing down everything his mentor passed on to him. After serving a two year apprenticeship, Sam acquired his pilot's certificate, plying his trade voraciously until, four years later, circumstances changed his life. There was a war to be fought and Sam gave up the life of a riverboat pilot, a profession he "...loved far better than any that followed, and took measureless pride in. The reason is plain: a pilot, in those days, was the only unfettered and entirely independent human being that lived in the earth."

Upon fulfilling his duty, Sam changed careers, becoming a newspaper reporter in Nevada. Though far from home, he never forgot how much the river had impacted his life and how much he loved it. It would become a recurring theme in many of his writings. Desirous of always having a connection with his past, Sam pondered how he might best do this. After much thought, he had a "eureka" moment. While on the river, one of his duties was to ensure his steamboat always traveled at a safe depth – then considered to be no less than 2 fathoms (12 feet). This depth was measured with a weighted line dropped to the river bottom, marked every fathom (6 feet). Crewmembers knew the water was deep enough to proceed when the second mark on the line disappeared below the surface and, utilizing the archaic term for "two", they would holler to the pilot "mark twain."

Thus, Samuel Clemens, a river rat, boatman, deckhand and pilot, became Mark Twain, an American icon.

Vessel Security/ Tank Barge Awareness

One of the areas C&B Marine wishes to grow is the ability to move tanks barges. To do that, each vessel must have a security plan and that plan must be enforced by the onboard crew. Please do not take this issue lightly because our customers do NOT. They understand it is the requirement for having the ability to move these hazardous cargos. Along with the ability to move them, comes the responsibility to move them safely. As your crew is trained in vessel security, you will be involved in discussions on tank barge awareness. This will describe the restricted areas of a tank barge, cargo awareness, barge inspection process and what is expected of the crew that has these barges in tow. The management team at C&B Marine is relying on all of our leaders within the company, both on the deck and in the wheelhouse, to help us in this process.

Man Overboard!!

As a crewmember in the towing industry, you are confronted with many different types of hazards in the workplace, the most prominent of them being the need to regularly perform routine tasks in close proximity to the edge of a boat or barge. Working near "overboard" hazards is something we have to deal with daily. Without adequate care, a fatal fall overboard can be a consequence. Prevention of man overboard incidents should be the number one goal of every boat and cleaning crew.

To prevent man overboard incidents, it is imperative to follow company policies and procedures. Listed below are several of C&B's "best practices":

- Avoid walking on outboard edges of the barge, except when absolutely necessary
- Carry loads on outside shoulder if it is necessary to walk on the outboard gunwale
- Loudly announce known "bumps" and brace yourself
- Never walk the notch
- Do not step on hatch covers
- Ensure hatch covers are closed
- Use the "buddy system" while on a tow
- Never go on a tow without notifying your pilot or fellow deckhand
- Discuss known hazards with the on-coming watch
- Never walk or stand on outboard gunwales when barges are coming together/closing up
- Never jump to/from moving equipment

When you sign a document, you are certifying the contents of that document. That signature makes you legally accountable! For example, when you sign the ERL and check that you inspected the MSD, and you're inspected by the Coast Guard and they notice that there are no chlorine tablets—you're liable. The MSD must have chlorine, and YOU signed and certified that it did. In this circumstance, the Coast Guard could hold you, as well as C & B, accountable. You are asked to sign many documents as a C & B employee and you must take it seriously each time that you do. When you sign a document, remember that YOU are certifying that YOU verified the information and acted accordingly.

Maintenance Tip of the Month - Fuel

It is currently the worst time of year for condensation in the fuel tanks. The river temperature is significantly cooler than the outside temperature, which results in condensation forming. Be sure to check your fuel at least 3 times per shift. If it is bright red, then you're good. If you see water, then bleed it into buckets until it is bright red. You cannot run a boat or equipment without good fuel.
